Winter is a great time to catch up on some reading. The Clearinghouse has just published our second Issues Paper, [***Measurement of family violence at a population level: What might be needed to develop reliable and valid family violence indicators?***](#) The paper reviews some of the available sources of data on family violence, assesses strengths and limitations of these data sources for measuring trends in family violence, and seeks to assist the reader to develop an understanding of the issues associated with family violence data collections. It suggests some future courses of action which could support the development of reliable and valid family violence indicators.
