Well done to everyone who has been involved in [White Ribbon](#) events. After a hectic few weeks, we hope you now have time to catch up on some reading before the equally busy festive season begins.

News, views, and happenings in brief:

- The global [16 Days of Activism against Gender Violence](#) campaign began on 25 November and runs to 10 December.
- Just published is [Masculine Empire: how men use violence to keep women in line](#), written by University of Auckland Associate Professor Peter Adams. This is essential reading for anyone working with men who perpetrate violence against women.
- Two reports evaluating New Zealand programmes have recently been published. One shows the promising results that the [Early Start programme](#) has achieved in reducing physical child abuse; the other reports on the progress of the [Violence Intervention Programme](#) in hospitals 96 months after implementation.
- UN Women in collaboration with other international bodies has published a report and a series of expert papers on the [primary prevention of violence against women and girls](#).
- Discussion of the impact of the legal system on victims/survivors of family violence continues, with a seminar on research into [women's experiences of the Family Court](#). The Law Society has produced a series of [Fact Sheets](#) on the Government's proposed changes to the Family Court and retiring Principal Family Court Judge Peter Boshier has [called for domestic violence to be a stand-alone criminal offence](#).
