The Government has announced a [package of Justice sector measures](#) to address family violence, estimated to cost an extra \$9.4 million over 4 years. It has also released the [report of the Expert Advisory Group on family violence](#) established in 2013, and released its response.

The Clearinghouse will be releasing our annual **data summaries** next week. We will send out a special update when these are available online.

Other news, views, and happenings in brief:

- The fourth [Family Violence Death Review Committee report](#) published in June provides an in-depth analysis of family violence homicides between 2009 and 2012, and calls for change in how dangerous family violence is responded to.
- The [Vulnerable Children Bill](#) and the [Victims' Orders Against Violent Offenders Bill](#) have passed their final reading in Parliament.
- Many [community providers are boycotting the pilot of the new Corrections programme](#) for domestic violence offenders.
- The [First Glenn Inquiry report](#) has been released.
- Child, Youth and Family has released their report on the [review of social worker caseloads, casework and workload management](#).
- The theme for this year's [16 Days of Action Against Gender-Based Violence Campaign](#) has been announced: militarism.

Tip of the month

Using the Clearinghouse to inform practice

Reading and applying research is a critical part of working effectively to prevent and respond to family and whānau violence. We know many of you do this already. For those newer to the Clearinghouse, some tips that may be useful are below:

- If you're developing a new resource, programme, policy or practice guideline, get into the habit of looking to the research as a starting place. Have evaluations of similar programmes or resources been done before? [Search the Clearinghouse library](#) to find out.
- If you're writing a submission, look at what research has found about the issue. Submissions are stronger when they're informed by research as well as your organisation's work and practitioner knowledge. [Search the Clearinghouse library](#) to see what the research says.
- Foster practices of learning, exchange and a "culture of curiosity" in your organisation. For example, pick a new research report or article from the [Clearinghouse newsletter](#) to discuss in your team or staff meetings. What are its implications for the way you work?
- When new staff start in your organisation, let them know about the Clearinghouse and [sign them up](#) for the newsletter.
