Kathryn's story: How the Government spent well over \$100,000 and 15 years pursuing a chronically-ill beneficiary mother for a debt she should not have. Auckland, New Zealand: Child Poverty Action Group.

Summary: In CPAG's report *The complexities of relationship in the welfare system and the consequences for children*, CPAG found serious misunderstandings and anomalies in the way mothers with children are treated in the welfare and judicial system. CPAG wrote about the famous Ruka v Department of Social Welfare case on the role of domestic violence in establishing relationship status. CPAG also discussed the learning from that case, and the subsequent evaluation by Barrister Frances Joychild in 1999.
