

Literature review of research into the effectiveness of self defence programmes for girls as a sexual violence and family violence prevention strategy. Wellington, New Zealand: Ministry of Social Development.

Summary: Gray Matter Research conducted an independent literature review of research and evaluations into the effectiveness of self defence programmes as a sexual violence and family violence prevention strategy for school-age girls. The report was commissioned to help ensure that Ministry funding decisions align with Community Investment outcomes and cross-government strategies on sexual violence and family violence... Safer sooner: Strengthening New Zealand's family violence laws. Wellington, New Zealand: Ministry of Justice.

Summary: On 13 September 2016, the Government announced a package proposing a broad overhaul of family violence legislation, stemming from the comprehensive review of the 20-year old Domestic Violence Act. From family group conferencing to Whānau Ora: Māori social workers talk about their experiences. A thesis presented in partial fulfilment of the requirements for the degree of Master of Social Work in Social Work, Massey University, Manawatu.

Summary: This thesis explored the challenges faced by seven very experienced Māori social workers within the care and protection system. Pacific peoples in New Zealand. Wellington, New Zealand: Pasefika Proud, Ministry of Social Development.

Summary: Samoan, Cook Islands Māori, Tongan, Niuean, Fijian, Tokelauan, Tuvaluan and Kiribati comprise the eight main Pacific ethnic groups in New Zealand. For the purposes of comparing high level ethnic groups in New Zealand they are referred to collectively as 'Pacific peoples'. This publication provides a snapshot of data, presented with infographics, of the socio-demographic characteristics of Pacific peoples in New Zealand, including a focus on family violence and experiences with Child, Youth and Family... Our voices. Our rights. Wellington, New Zealand: Save the Children New Zealand & Unicef New Zealand.

Summary: Save the Children and UNICEF's youth ambassadors were asked to write a report about the lives and wishes of children in Aotearoa New Zealand. They asked 1198 children about their thoughts, experiences and opinions. Their report, Our Voices Our Rights provides a window into childhood within New Zealand. Toy-Cronin, B.A. (2015).

Keeping up appearances: Accessing New Zealand's civil courts as a litigant in person. A thesis submitted for the degree of Doctor of Philosophy, University of Otago.

Summary: Using several qualitative methods including interviews, document review and participant observation, this thesis asks, first, why are litigants going to New Zealand's civil courts without a lawyer? Second, what is their experience of litigating in person? Third, how do the inhabitants of the court system - the judges, lawyers and court staff - perceive litigants in person and respond to them?... [Read more](#)

Biculturalism as an approach to social work. In: H. K. Ling, J. Martin & R. Ow (Eds.), *Cross-cultural social work: Local and global*. (pp. 67-85). Melbourne, Vic.: Palgrave Macmillan.

Summary: As a profession, social work in New Zealand has shown leadership among the 'people professions' by requiring its practitioners to be competent in working across cultures: in particular with Māori, the nation's indigenous people. The high number of Māori who come to the notice of authorities has meant that aspiring social workers are required to have a base knowledge of Māori cultural constructs (tikanga), have undertaken an introductory course into the Māori language (reo), and be aware of how to uphold and apply the Treaty of Waitangi. This chapter looks at how and why social work students are trained to work biculturally in the first instance and from there develop a multicultural approach... [Read more](#)

Substantiation decision-making and risk prediction in child protection.

Policy Quarterly, 12(2): 46-56.

Summary: In the last few years, predictive risk modelling has been suggested for use in the child welfare environment as an efficient means of targeting preventive resources and improving practitioner decision-making. First raised in the green paper on vulnerable children, then translated into the white paper on vulnerable children and the Children's Action Plan, and now part of the Child, Youth and Family review remit, this particular tool has provoked a barrage of opinions and wide-ranging analyses... The teaching of Māori social work practice and theory to a predominantly Pākehā audience.

Aotearoa New Zealand Social Work, 24(3&4): 65-74 (Open access).

Summary: This article will explore the practices of teaching social work students in Aotearoa New Zealand to equip them for bicultural practice. This includes te reo Māori (the Māori language) and tikanga (culture) papers as well as specific teaching on the Treaty of Waitangi provisions. It will discuss some of the results, which suggest students know about Treaty provisions but are less able to translate this knowledge into practices, which are bicultural. It then suggests some strategies for moving this teaching forward so that students start to feel accustomed to and confident in practices which are suited to a bicultural setting... [Read more](#)

Safe not sorry: Supporting the campaign for safer child contact. Bristol, England: Women's Aid.

Summary: Existing research provides strong evidence that in

making arrangements for child contact when there is a history of domestic violence, the current workings of the Family Justice System support a pro-contact approach that neglects the safety needs of children and women, and the impact on them of previous or continuing domestic violence. This frequently exposes children and women to further violence, causes them significant harm, and prevents their recovery. For a substantial number of children, the privileging of men's rights to contact over children's welfare negatively affects every aspect of their wellbeing and development. The individual and societal costs are unacceptable. This review of research focuses on the safety and wellbeing of children when having contact, whilst also acknowledging that this is related to the safety of women...

Sexual assault and older women: A critical review of the literature.

Trauma, Violence & Abuse, Advance online publication, 31 March 2016.

Summary: This article provides a critical review of current literature on the sexual assault of older women - including an exploration of the specific features and emotional and physical impacts of older women's experiences - and highlights current gaps and future directions for research, practice, and theory. A review of the literature indicates that older women constitute only a small proportion of victim/survivors. However, there is evidence to suggest that existing research underestimates the extent of this issue... [Read more](#)

Indirect abuse involving children during the separation process.

Journal of Interpersonal Violence, Advance online publication, 27 July 2015.

Summary: Separation is believed to be an antidote to risk abusers pose to their partners and children and underlines many interventions in family, juvenile, and criminal court proceedings. Countering this belief is the claim that many abusers respond to the felt loss of power and control occasioned by separation by changing or escalating abusive tactics. This study complements research on post-separation by asking whether separation is associated with an increase in threats of indirect abuse, which relies on third parties to manipulate the victim... Sexual violence in the digital age: The scope and limits of criminal law.

Social & Legal Studies, 25(4): 397-418.

Summary: Considerable scholarly attention has been paid to a range of criminal behaviours that are perpetrated with the aid of digital technologies. Much of this focus, however, has been on high-tech computer crimes, such as hacking, online fraud and identity theft, or child exploitation material and cyberbullying. Less attention has been paid to 'technology-facilitated sexual violence', where new technologies are used as tools to perpetrate or extend the harm of a sexual assault, extend control and abuse in a domestic violence situation, or distribute sexual or intimate images of another without their consent. Secondary victimization: Domestic violence survivors navigating the family law system.

Violence Against women, Advance online publication, 23 August 2016.

Summary: This qualitative study explored the experiences of 22 domestic violence survivors attempting to negotiate safe post-separation parenting arrangements through the Australian family law system. What do young people think about their school-based sex and relationship education? A qualitative synthesis of young people's views and experiences.

Summary: The authors aimed to investigate whether current provision of sex and relationship education (SRE) meets young people's needs in the United Kingdom. To do this the authors conducted a synthesis of qualitative studies of young people's views of their school-based SRE. Exploring couples' processes of change in the context of SASA!, a violence against women and HIV prevention intervention in Uganda.

Prevention Science, Advance online publication, 29 September 2016 (Open access).

Summary: There is now a growing body of research indicating that prevention interventions can reduce intimate partner violence (IPV); much less is known, however, about how couples exposed to these interventions experience the change process, particularly in low-income countries. Understanding the dynamic process that brings about the cessation of IPV is essential for understanding how interventions work (or don't) to reduce IPV. This study aimed to provide a better understanding of how couples' involvement with SASA! - a violence against women and HIV-related community mobilisation intervention developed by Raising Voices in Uganda - influenced processes of change in relationships. Qualitative data were collected from each partner in separate in-depth interviews following the intervention. Dyadic analysis was conducted using framework analysis methods. Study findings... Flexible funding as a promising strategy to prevent homelessness for survivors of intimate partner violence.

Journal of Interpersonal Violence, Advance online publication, 12 August 2016.

Summary: The complex interrelationship between intimate partner violence (IPV) victimization and housing instability has been well established. Being the victim of IPV is a leading cause of homelessness for women, and once someone is homeless, their lives often spiral downward quickly. While some IPV survivors require extensive and possibly long-term assistance to achieve safe and stable housing (especially if they are contending with multiple complex issues), others could avoid homelessness if provided with immediate, individualized, and flexible assistance... Exploring rape culture in social media forums .

Computers in Human Behavior, 63: 922-927.

Summary: Current research has yet to examine the phenomenon of rape culture, particularly within social media forums. The present study investigated the attitudes about

rape, rapists, and gender-based violence within the comments section of newspaper articles reporting about rape and sexual assault. Naturalistic observation was used in order to gather statements within the comment sections following newspaper articles posted on either the periodical website or the periodical's Facebook page...
