A number of adverse outcomes are recognized in terms of mental health, behavioral, and relational difficulties. However, research also indicates that there is potential for healing. Drawing on interviews from the Australian Homicide Project with a sample of men convicted of killing intimate partners, the authors examine the backgrounds of perpetrators and the contexts in which the killings occurred and find that fully half report no physical or sexual assaults against their partners in the year prior to the homicide...
