**Mental illness among women referred for psychiatric services in a New Zealand women's prison.**

*Behavioral Sciences & the Law*, Advance online publication, 7 April 2016

*Summary:* This naturalistic exploratory study describes the characteristics of women prisoners referred to the forensic psychiatry service of the largest women's prison in New Zealand. Forensic psychiatrists diagnosed more than one-third of the referred female inmates with psychotic disorders, and they diagnosed post-traumatic stress disorder in one-fifth. The majority of the women reported substance use prior to incarceration, as well as a history of personal victimisation by family violence... [Read more](#)

**Intimate partner violence and women's reproductive health.**

*Summary:* Intimate partner violence (IPV) is common among women. An estimated 30% of all women globally report experiencing physical or sexual violence by a husband, intimate partner or ex-partner. It is important for those working in reproductive health settings to be aware that sexual assault can occur in the context of relationships. IPV can also include reproductive and sexual coercion. **Changing values: Attitudes about intimate partner violence in immigrants and natives in five Western countries.**

*Deviant Behavior*, 38(3); 241-253

*Summary:* This article explores attitudes about Intimate Partner Violence Against Women (IPVAW) amongst immigrant (first and second generation) and native populations in five post-industrial societies (Germany, Netherlands, New Zealand, Sweden, and USA). Note that the term "natives" refers to respondents born in the country surveyed. In this article "second generation"

respondents are those where both their mother and father were born outside the surveyed country. Using the sixth wave of World Values Survey, the authors conclude that there are significant differences... [Read more](#)

**Mobilising culture against domestic violence in migrant and ethnic communities: Practitioner perspectives from Aotearoa/New Zealand.**
