Social investment: A New Zealand policy experiment

Summary: For almost a decade, the idea of social investment has been a major focus of New Zealand policy-making and policy debate. The broad aim has been to address serious social problems and improve long-term fiscal outcomes by drawing on big data and deploying various analytical techniques to enable more evidence-informed policy interventions. But recent approaches to social investment have been controversial. In late 2017, the new Labour-New Zealand First government announced a review of the previous government's policies. As ideas about social investment evolve, this book brings together leading academics, commentators and policy analysts from the public and private sectors to answer three big questions... The reason for producing an article on Māori participants is that, as heavy users of GRG, they have carved out their own approaches to negotiating the role of grandparents bringing up their children's children (mokopuna or moko)...

Accelerate progress - sexual and reproductive health and rights for all: Report of the Guttmacher-Lancet Commission

Summary: Sexual and reproductive health and rights (SRHR) are essential for sustainable development because of their links to gender equality and women's wellbeing, their impact on maternal, newborn, child, and adolescent health, and their roles in shaping future economic development and environmental sustainability. Yet progress towards fulfilling SRHR for all has been stymied because of weak political commitment, inadequate resources, persistent discrimination against women and girls, and an unwillingness to address issues related to sexuality openly and comprehensively. To address this unfinished agenda, this 2018 Guttmacher-Lancet Commission proposes a new, comprehensive definition of sexual and reproductive health and rights, an associated essential package of health services, and outlines actions needed beyond the health sector to change social norms, laws, and policies to uphold human rights... The #MeToo movement presents an opportunity for the public health community to consider sexual harassment a health issue with implications for disease prevention and health promotion...
