

### **Health and wellbeing of Māori secondary school students in New Zealand: Trends between 2001, 2007 and 2012**

#### **Manhood 2.0: A curriculum promoting a gender-equitable future of manhood**

**Summary:** Manhood 2.0 is a gender-transformative curriculum developed by Promundo and the University of Pittsburgh to engage young men aged 15 to 24 in reflecting on the impacts of harmful gender norms, specifically those surrounding issues such as teen pregnancy prevention, dating violence and sexual assault, and the bullying of lesbian, gay, bisexual, transgender, and queer (LGBTQ) individuals. ### **Three principles to improve outcomes for children and families**

*Summary:* Recent advances in the science of brain development offer us an unprecedented opportunity to solve some of society's most challenging problems, from widening disparities in school achievement and economic productivity to costly health problems across the lifespan. Understanding how the experiences children have starting at birth, even prenatally, affect lifelong outcomes - combined with new knowledge about the core capabilities adults need to thrive as parents and in the workplace - provides a strong foundation upon which policymakers and civic leaders can design a shared and more effective agenda... ### **Understanding elder abuse: A scoping study**

*Summary:* This review begins with a broad discussion of elder abuse by considering the definition of the term and the prevalence of the behaviour, the impact elder abuse has on older people and the wider population, and the family context within which elder abuse most often occurs. It then considers the different ways elder abuse is conceptualised, and how it intersects with a range of other issues including ageism, family violence and conflict, caregiving, gender and sexuality, and culture and suggests that an applied ecological approach (which considers the individual and their place within their community and society) is the most comprehensive way of conceptualising elder abuse... ## **"What about my right not to be abused?": Domestic abuse, human rights and the family courts**

**Summary:** This research examines women survivors of domestic abuse's experiences of the family courts in the United Kingdom, looking at these experiences through the lens of human rights. Talking to survivors about rights - using plain language around the right to a fair trial and the right to life - helped to uncover stark problems with culture and practice in the family courts that affect the courts' ability to do justice, safeguard against further trauma, and prioritise children's safety... #### **Attitudinal support for violence against women: What a population-level survey of the Australian community can and cannot tell us**

**Summary:** Societal level norms, practices and structures are among the factors contributing to it, sometimes referred to collectively as representing "cultures of support" for VAW. Understanding factors contributing to these cultures is important for prevention, but remains the subject of debate. #### **#HowIWillChange and gaps in Twitter discourse**

**Summary:** Twitter has rapidly gained popularity as a space for the public to discuss sexual violence (SV) prevention due to a number of high-profile SV cases. This study aimed to examine Twitter discourse on SV prevention through the hashtag #HowIWillChange, which encouraged Twitter users to come forward and report plans to engage in bystander prevention. The authors analyzed 1,493 #HowIWillChange tweets from October 2017 through a directed content analysis approach rooted in an evidence-based framework for the continuum of bystander intervention... #### **The perils and pitfalls of formal equality in Australian family law reform**

**Summary:** In this paper, the authors identify the influence of formal equality - and more specifically, formal gender equality (that is, treating men and women the same) - in central areas of major Australian family law reform over the past 20 years. Given the influence of formal equality and concerns regarding this trend, the authors consider whether equality-based arguments should be abandoned entirely, at least in the family law context, and explore alternative approaches that could reframe the debate... #### **Psychological advocacy towards healing (PATH): A randomized controlled trial of a psychological intervention in a domestic violence service setting**

**Summary:** Experience of domestic violence and abuse (DVA) is

associated with mental illness. Advocacy has little effect on mental health outcomes of female DVA survivors and there is uncertainty about the effectiveness of psychological interventions for this population. **Women's experiences of a randomised controlled trial of a specialist psychological advocacy intervention following domestic violence: A nested qualitative study**
