Of note is consultation by Te Tari Taiwhenua | Department of Internal Affairs asking for feedback on a new system for keeping people safe online.

In other news, this week the [Office of the Auditor-General \(OAG\) released their second audit of Te Puna Aonui](#), formerly the Joint Venture. This audit focused on how the 10 agencies involved with Te Puna Aonui worked individually, together, and with tangata whenua, communities, and non-government organisations to understand and respond to the needs of people affected by family violence and sexual violence. Finally, in recognition of [World Elder Abuse Awareness Day](#) (15th of June), we have published a news story highlighting research about gender-based violence later in life. The story includes new resources and information about government investment into elder abuse.
